Each year, an estimated 560 million PET bottles are wasted due to labels that are incompatible with the recycling process. These bottles are recycled into lower-quality plastics, or simply deposited into landfills. At the same time, demand for high-quality recycled PET is growing.



Our CleanFlake Adhesive Technology eliminates the incompatibility, allowing pressure-sensitive labels to separate cleanly from PET bottles. The resulting pure PET flakes can be 100 percent recycled into food-grade bottles and thermoform containers. This increases the overall recycling yield and the availability of rPET. And, it helps you meet the growing demand for recycling-compatible labels.

The portfolio, which previously launched for film products, has now expanded to include paper facestocks, enabling converters to offer CleanFlake technology for film and paper labels. The portfolio features a proprietary adhesive that's compliant with the EU's REACH (Regulation, Evaluation, Authorization, and Restriction of Chemicals) regulation. The products are easy-to-use, and otherwise identical to other pressure-sensitive materials. Converting requires neither new nor retooled equipment.
